## INFORMAL NOTICE PROPOSED STREET IMPROVEMENTS - WALNUT STREET RECONSTRUCTION BLOOMFIELD, IOWA - 2025 PROJECT No. 25-024

General Nature of Public Improvement

Proposed Street Improvements - Walnut Street Reconstruction - Bloomfield, Iowa - 2025.

The project includes approximately 1,650 SY of pavement replacement with PCC on Walnut Street between Madison Street and Washington Street.

### Time and Place for Filing Sealed Bids

Sealed bids for the work comprising each improvement as stated above must be filed before 4:00 P.M. on July 17, 2025, in the office of the City Clerk at the City Hall, 111 West Franklin, Bloomfield, lowa.

Time for Commencement and Completion of Work. The work under the proposed Contract shall commence upon issuance of the written Notice to Proceed. The proposed street improvements improvements listed shall be fully completed on or before November 20, 2025. The Bidder agrees to pay as liquindated damages the sum of \$500 for each consecutive calendar day after the specified completion date that the project is not fully completed.

Contract Documents. Drawings and specifications governing the construction of the proposed improvements have been prepared by French-Reneker-Associates, Inc., Engineers and Surveyors, Fairfield, Iowa. The contract documents may be examined at the office of the City Clerk. The BIDDER understands that the OWNER reserves the right to reject any or all bids or to waive any formality or technicality in any bid in the interest of the OWNER.
