WRITTEN ACTION BY CONSENT FOR THE TERMINATION OF 28E ENTITY

The City of Bloomfield, Iowa, an Iowa municipal corporation ("City"), Northeast Missouri Electric Power Cooperative, a Missouri Cooperative ("NE Power"), and Southern Iowa Electric Cooperative, and Iowa Cooperative ("SIEC") are Parties to a 28E Agreement dated February 8, 2006, which dealt with the construction of a speculative shell building in Bloomfield, Iowa and the financing of the same.

Section I of the 28E Agreement provides that this agreement shall continue until such time as (1) the speculative shell building is sold or (2) the Revolving Loan Fund loan from SIEC to DCDC is repaid in full and any promissory notes payable by DCDC to the City, NE Power, and SIEC are paid in full, whichever is the later to occur.

The speculative shell building has been sold, and the Revolving Loan Fund loan has been paid in full.

The undersigned Parties to the 28E Agreement hereby elect to dissolve and terminate the 28E Entity.

The 28E Entity assets have been distributed and there are no assets to distribute.

The City of Bloomfield shall be vested with the authority to take any and all additional actions necessary to dissolve the 28E Entity, including filing notice of termination with the Iowa Secretary of State.
