Motion by Howard, second by Walton to approve moving forward with offering a Development Agreement with SKP Industrial. The Agreement offered will be up to \$50,000 for primary installation of utilities. In addition to the utilities installation, the City is willing to pay 75% of Tax Increments per fiscal year for up to 10 years or a total of \$80,000, whichever occurs first. Payments will begin March 1, 2025 and end December 31, 2034 assuming the land owner and developer file annual certification by October 15th per year and the City certifies debt to the County prior to December 1 each year pursuant to Section 403.19 of the Urban Renewal Act. AYE: Bohi, Howard, Spargur Walton NAY: None Motion carried.

Motion by Bohi, second by Walton to approve moving forward with offering a Development Agreement with Metal Wholesale. The Agreement offered will be up to \$130,000. The City is willing to pay 75% of Tax Increments per fiscal year for up to 10 years or a total of \$130,000,

whichever occurs first. Payments will begin March 1, 2025 and end December 31, 2034 assuming the land owner and developer file annual certification by October 15th per year and the City certifies debt to the County prior to December 1 each year pursuant to Section 403.19 of the Urban Renewal Act.
