HOTEL/MOTEL TAX FUNDING REQUEST

The B. F. Carroll Chapter Izaak Walton League located near Lake Fisher in Davis Co. has partnered with the Davis County Law Enforcement to up grade the current rifle and pistol range facilities on the property owned by the Chapter. This range will be used by City and County departments for training and yearly certifications. This will be in addition to range use by members and sponsored programs such as the Davis County 4-H shooting sports program, the Appleseed youth marksmanship program, and other organized groups. The construction of the new range facilities has been made possible with grant monies and is in various stages of completion. This was a very ambitious undertaking with construction cost estimates of \$65,000.00. We have been fortunate to receive grants of \$25,000.00 and \$5,000.00 that has enabled us to do most of the major dirt work to construct the berms and one drive and parking area. This point of construction allows use of the pistol range by law enforcement and the 4-H rimfire program. We are seeking funds to allow us to finish construction of a concrete firing line and handicap accessible walks to allow access for several shooters with disabilities. We also have several military Veterans expressing their wish to participate and this would also serve them.

The current situation with the Covid-19 Virus has prevented us from any activities or further construction. We rely on two major fund raisers to support chapter expenses and upkeep of the Chapter house and facilities. Concessions at the Davis County Fair and the Drakesville Old Soldiers and Settlers Reunion are our main source of income. Both are in danger of being canceled at the time of writing this application. Our finances are such that we can weather this event, but do not allow for any additional expenses associated with completion of our project. With the interest generated by this project we anticipate increased participation and we have had inquiries from other communities. We see this as being beneficial to Bloomfield and Davis County through tourism and business.
