1. Approve City Council minutes, March 5, 2020

Discussion was held with Nancy Devereaux regarding Ash trees she had removed from the City’s right-of-way prior to the City removing Ash trees throughout the City. Also discussed was storm water washing out her driveway. Council

directed City Administrator Morris, Councilman Bohi, and Streets Superintendent Wagler to look at her property and report back to the Council.

Council discussed hiring an interim DPW. City needs someone to oversee the public works projects we have coming up. Richard Wilcox has experience and is willing to help out. Morris was directed to contact Wilcox and discuss the interim position. Morris will have a contract drawn up and present at the next meeting if Wilcox is still interested.

Discussion was held regarding the sponsored project. Those present like the idea of permeable pavers in front of the elementary school. They do have concerns about bus traffic and the weight on the pavers. Council directed Morris to contact HR Green regarding these issues.

Motion by Howard, second by Bohi to approve a confidentiality agreement with JP Jones regarding data he is given to analyze from the solar field.

Motion by Cronin, second by Bohi to extend the city administrator contract with Andrew Morris for one (1) month, till the end of April, while we obtain an agreement for a long-term relationship.
