WHEREAS, the City of Bloomfield (hereinafter CITY) is an Iowa municipal corporation and is authorized to sell land pursuant to the provisions of §364.7 of the Code of Iowa; and

WHEREAS, the CITY has determined that it would be in the best interest of the CITY to sell certain property owned by the CITY and located to the east of Parcel No. 10102250 (on the records of the Davis County Assessor) owned by Barry and Dana Day from Karr Avenue north to the abandoned railroad right-of-way to be more definitely described in a survey to be completed at the expense of Barry and Dana Day; and

WHEREAS, before the property may be sold, it is necessary to conduct a public hearing on the proposal to sell property all as required and provided by §364.7 of the Code of Iowa (2019).
