The Bloomfield City Council met in special session at 7:00pm at the Bloomfield Public Library with the following members present:

Mayor Miller called the meeting to order and welcomed those present.

**Public Hearing:**

**Public Comments:**

The Board members suggested a new group of people be formed (as has been in the past) with the School Board, City Council, Southern Iowa Electric, Citizens Mutual, and the County.
