#### 7. The nature of the proposed activities:

 City Park Playground Project is replacing a 20+ year old playground equipment and original playground equipment from when the park was initially built that is not safe and not all inclusive for children of all ages and abilities with a new 10,000 sq. ft. playground that is upgraded with safety features and provides all-inclusive play for all children's

- abilities. This project will also provide a new and safe area that children can play on outdoors and use safely with social distancing.
- o Lower Playground and Courts Project is upgrading the lower family recreational area with a younger style playground suitable for the young children of families that are partaking in outdoor activities such as basketball, pickle ball, baseball or softball. This project will install a 3,000 sq. ft. playground and directly adjacent to the new concrete pad being used for basketball and pickle ball. Shade features have already been purchased through the Wellmark Grant for the basketball courts. This project will also allow the installation of a safety sport court to help prevent injuries on the new basketball courts and better the environment for outdoor recreation.
- Mutchler Community Center New HVAC System project will replace the HVAC system (installed in 1999 with the original build) that is over 20 years old and is not maintaining temperatures correctly and is struggling with air filtration and distribution properly throughout the building. The new system will improve temperature control and assist with proper ventilation and airflow.
- City of Bloomfield Commercial Façade Improvement grant applications are to help with funding to eliminate slum and blight and improve commercial façade in districts impacted by COVID-19. These projects are exterior improvements only, removal and replacement of glass is probably the most intrusive work, but can be accomplished in a day or two with temporary partitions to the interior if necessary. These projects include masonry repair and replacement, mortar repair, glass replacement that will only take part on the non-historic glazing systems and any exterior repairs to panels, concrete or limestone blocks. Any and all work will be reviewed by SHPO/IEDA with a 106 review since these are all considered historical buildings. This project aims to enhance and return the buildings to their historic glamor. This project is ensuring that the priority safety concerns are being repaired first and foremost.

## **Community Development and Housing Needs Assessment Clarification**

Community Development and Housing Needs of LMI Persons

- Develop Outdoor Recreational Opportunities: The City currently has limited outdoor recreational opportunities and has been working with a local trail organization to create a trail that stretches from one side of Bloomfield to the other side, which will create not only an outdoor recreational opportunity, but also helps residents get from one location to another location safely when they don't have access to a means of transportation. The City would also like to install new outdoor playground equipment, upgrade the public pool and install sport courts that will connect to the trail network. (LOW)
  - CLARIFICATION: The City of Bloomfield had a long list of improvements to complete on the City Pool that was separated into two phases. Phase 1 included repairs of the concrete pool deck, rusted toilet stalls, replacing bathroom ventilation systems, repairing and adding shade features, updating lighting to LED and repainting the main pool. Phase 2 of the project would include adding a splash pad and upgrading the baby pool area. The City applied for grant funding through the Land & Water Conservation Fund (LWCF) in March 2020, right before the pandemic hit for Phase 1 of the project. After it was awarded in April 2020, it came to a stand-still due to the pandemic. Due to the drastic time it took for the contract and additional paperwork to get completed, LWCF issued a Notice of Waiver of Retroactivity in August 2021 to allow the City to start the project, since it had been over a year since it was awarded. The City began the process of procuring service providers for the various projects within the LWCF funding. Projects that have been completed to date (March 2022) for the LWCF project include repairs and painting of the pool bottom. Bathroom stalls and LED lights have been ordered. The City is still working on finding funding to complete Phase 2.
  - <u>CLARIFICATION</u>: The City of Bloomfield applied for the Wellmark Small Match Grant fund in June 2020 to build a new basketball/pickleball court with (2) hoops, fencing around the courts, bleachers, picnic tables, shade features, LED lighting and to add a grass section in between the courts and the baseball batting cage currently located to the West of the project area. Due to the pandemic and supply/cost issues, this grant had to adjust its construction plan and completed the project in December 2021. The adjustments included adding fencing only on the side between the courts and the parking lot and the concrete area was built smaller to allow for a future toddler-small

child playground and play area for families using the community facilities. This project did not include the sport court or lines for the concrete basketball/pickleball court.

- Please clarify why the City decided to prioritize an application for Playground upgrades (priority LOW), especially when two playgrounds already exist, over applying for funds for a new air conditioning/HVAC system in the community center (priority MEDIUM).
  - o CLARIFICATION: The City determined that they need were as listed below:
    - Sanitary Sewer Improvements: HIGH In process
    - Housing Rehabilitation: HIGH In process
    - Rehabilitation of Downtown Buildings: MEDIUM applying for CDBG-CV funding
    - Community Center Improvements: MEDIUM applying for CDBG-CV funding
    - Encourage Development of New Housing: MEDIUM In process
    - Develop Outdoor Recreational Opportunities: LOW applying for CDBG-CV funding
  - o CLARIFICATION: The City is applying for CDBG-CV funding for the remaining projects that are not in process. The City Park Project was submitted with plans to submit the Mutchler Center HVAC project once the estimate was complete the following week, which was the same week that "clarifications" were requested with a new Public Hearing. The two existing playgrounds are both old and dilapidated areas, details on these locations can be found in the "Clarification on current parks available in the City of Bloomfield". All projects that are not in process with other funding sources, are being requested for CDBG-CV funding.
