City Administrator: Asked for input as to how the Council wanted the Community Development monies distributed. Don Walton suggested that Main Street gets \$30,000 and then the next \$20,000 is given as a matching fund to monies raised by Main Street. Historic Preservation will get an additional \$20,000 for a total of \$30,000. The remaining funds will be distributed as follows: MCC \$7500, Historical Society \$1500, Senior Center \$2000, Tourism \$2000, DCDC \$10000, Other \$7000 for a total of \$110,000.

Director of Public Works: The two newest members of the gas dept are at Gas Boot Camp. Working on leak at the pool. Will do the Shower House floor at the pool this fall. Street work will be starting soon. The tree dump is ready to go. Just waiting on the weather to dry things out to finish setting it up.

Community Development Director: Make-my-Move has referred 61 names. Out of those, 32 emails were sent and there have been 10 responses.

CDBG-CV grants worth \$33 million have been submitted.
