### **Police**

- Starting a new program in April called "Handle with Care". Partnering with Southern Iowa Mental Health and schools to help children who have been in disruptive situations.
- Have tried to be more proactive this year. Year-to-Date, there have been 140 more encounters than in 2021.

### **Fire/Code Enforcement**

- Busy with planned and unplanned fires. Got Lake Fisher burned off.
- Article in newspaper regarding Code Enforcements. There was an error on the leaves and grass clippings and wood chips item. There will be no burning, there will be a compost pile for these items.

### Director of Public Works

- Removed worn banners around the square
