AN ORDINANCE TO AMEND THE CODE OF ORDINANCES OF THE CITY OF BLOOMFIELD, IOWA, BY AMENDED THE FEES FOR WATER, SEWER, ELECTRIC AND GAS SERVICE, REPEALING ALL ORDINANCES IN CONFLICT AND ESTABLISHING AN EFFECTIVE DATE.

**BE IT ENACTED**, by the City Council for the City of Bloomfield, Iowa, that:

<u>Section One</u>. Chapter 92.02 of the Code of Ordinances of the City of Bloomfield is amended to read as follows:

92.02 **RATES FOR SERVICE**. Rates for water service for all customers of the City of Bloomfield are as follows:

Facility Charge	\$30.00 per month
Usage Charge	No usage charge for up to 1,000 gallons
	\$10.50 per 1,000 gallons for usage over 1,000
	gallons in a month

On or before the 1<sup>st</sup> day of February of each year, the City Clerk shall compute an adjustment to the water rates based on the multiplication of the current rate by a factor equal to the increase in the Consumer Price Index (C.P.I.) as established by the Federal government for the preceding twelve (12) month period (January 1 to December 31). This adjustment shall be submitted to the City Council at the first Council meeting in February. At the Council's discretion, this adjustment may be applied to the minimum bill on the 1<sup>st</sup> day of the following month.

<u>Section Two</u>. Chapter 99.02 of the Code of Ordinances of the City of Bloomfield is amended to read as follows:

99.02 **RATE**. Each customer shall pay sewer service charges for the use and for the service supplied by the municipal sanitary sewer system as follows:

Facility Charge	\$50.00 per month
Usage Charge	No usage charge for up to 2,000 gallons
	\$12.50 per 1,000 gallons for usage over 2,000
	gallons in a month

<u>Section Three</u>. Chapter 110.05 of the Code of Ordinances of the City of Bloomfield is amended to read as follows:

110.05 **RATES**. The rates for gas services for all categories (residential and commercial) are as follows:

Availability Charge	\$15.00 per month
Usage Charge	\$4.00 per 1,000 cubic feet (MCF), plus the

actual cost to the City for the City's purchase
of gas and the actual cost of transportation of
purchased gas to the City's border station

Section Four. Chapter 111.04 of the Code of Ordinances of the City of Bloomfield is amended to read as follows:

111.05 **RATES**. The rates for electric service are as follows:

Residential Within City Limits	Facility Charge	\$20.00 per month
Residential Outside City Limits	Usage Charge Facility Charge	\$0.1350 per kWh \$25.00 per month
	Usage Charge	\$0.1550 per kWh
Commercial	Facility Charge	\$35.00 per month
	Usage Charge	\$0.1250 per kWh
Industrial	Facility Charge	\$50.00 per month
	Usage Charge	\$0.075 per kWh
	Demand Charge	\$12.00 per kW Demand

Section Five. All ordinances, or parts of ordinances, in conflict herewith are hereby repealed to the extent of such conflict.

Section Six. This Amendment shall become effective on June 1, 2023, or as otherwise noted in the ordinance.
